140. PUBLIC FORUM

PC Matt Stonier informed the Council that planning was well in hand for the Jazz Festival. Speed checks had been carried out on Waterlode and Peter de Stapleigh Way. Waterlode was originally 40mph but the 30mph limit was now justified because of the residential development on either side.

Councillor Butterill thanked the police for the speed monitoring exercise on Birchin Lane. There is an issue in Manor Road with vehicles parking close to the junction. PC Matt Stonier confirmed that holders of blue badges should not park where they could cause obstruction and should nor park close to junctions.

Councillor Staley asked about the removal of the 30mph signs in Audlem Road. This will be checked.

The Mayor thanked PC Stonier for attending and reminded Councillors that Speedwatch volunteers were still required.

Mr David Fletcher updated the Town Council on the issues facing Transport for Wales since the takeover from Arriva Trains Wales. New trains should be operating within 2 years. A deep clean is planned at all stations. The growth is use of the 7.15 to Manchester is being monitored.
